5.0 NEW APPLICATIONS

CH025 - Jack Sawday - Purchase of a No Till Drill

5.1 The Applicant did not attend and the Farming Officer gave a short presentation to the LAP on his behalf. This project was for the purchase of a No Till Drill for the purpose of establishing cover crops over an increased area of the farm. The farm lies entirely within a Nitrate Vulnerable Zone and in close proximity to Chichester Harbour. The establishment of cover crops has many environmental benefits. Cover crops capture carbon and stores it in plant material improving soil health. Cover crops also improve soil structure and help to reduce nitrate leaching into nearby harbour waters thereby having a positive impact on water quality.

The Farming Officer Reported that this Moore Uni Drill would drill into grass and/or stubble and was a inexpensive and easy method of drilling. A member queried whether the method of control was a well established one. The Farming Officer responded that the drill had a mechanically driven metering unit and a hydraulic fan that blows the seed down the tubes, a cultivator then cuts the holes, slots the seed in and lifts. The metering system governs the rate of seed planting. A member queried the general legibility of the quotes provided and the Farming Officer agreed to send clearer copies to the LAP. A member commented that the values seemed correct, the drill was a basic model drill and a good purchase. The Farming Officer confirmed that the amount of grant claimed was based on the Farming Technology Fund standard rate.

5.2 Members agreed the scoring for the project as follows:
